Ongoing:

- **Chapter Meeting Attendance/Financial Reports** submit to National within 30 days of every meeting (Sec/Treasurer)
- **Chapter Officer Update** – newsletter will be emailed first week of every month to all Chapter Officers
- **Chapter Meeting Notices/Webpage Postings** – submit to National 4 weeks prior to the event date (access via website) (Comms Chair and Presidents have access)
- **Chapter Meeting Notices** – emailed from National to all Chapter members 2 weeks before events when requested (Comms Chair)
- **Chapter Event CEUs** – if CEU meetings will be longer than one hour, Chapters must submit a request for additional CEUs to Professional Development team (ceu@nkba.org) at least 4 weeks in advance of the event

 - o **Student Focused Event** - one student event per year will earn bonus student funding for the chapter; provide a brief description of your event on the [Chapter Meeting Financial Report Form](#) within 30 days of the event.
 - o **Affiliated School** - send National an email if you would like to recruit a school to join; must be submitted within 30 days of their join date.
